SPGP PRELIMINARY SCREENING PROCESS

The preliminary screening process is proposed to help expedite Corps review of delineations for permitting and federal coordination for Section 7, Section 106, Section 408, Tribal review, and EPA review. This process is proposed for use with 22-SPGP-RCIR and 22-SPGP-LT projects that occur within the Commonwealth of Virginia.

- A. When a project does not have a Corps confirmed delineation/jurisdictional determination the applicant will submit:
  - 1. A delineation report with data sheets and a delineation map that clearly identifies all waters, including wetlands, that are located within the project boundaries.
  - 2. A location map that clearly identifies the project boundaries and includes the latitude and longitude.
  - 3. The development plan that will be submitted with the permit application.
- B. When a project has a Corps confirmed delineation/jurisdictional determination the applicant will submit:
  - 1. A location map that clearly identifies the project boundaries and includes the longitude and latitude.
  - 2. The development plan that will be submitted with the permit application.
- C. Corps review:

The Corps project manager (PM) will review the preliminary screening request to determine the following:

- 1. If the delineation is acceptable for use with a permit application.
- 2. If Section 7 coordination is required.
- 3. If Section 106 coordination is required.
- 4. If Section 408 coordination is required.
- 5. If Tribal coordination is required.
- 6. If EPA coordination is required.
- 7. If the development plan is acceptable for federal coordination (when applicable).

\*The federal review portion of a preliminary screening is only valid for 9 months after Corps review. Applications received after the 9 months may require new federal review/federal coordination.

\*If the development plans change or federal review expires prior to application submittal, federal review and federal coordination will be completed through the SPGP permit process.
